A. Superintendent Report

Swamp Leak - The cost to date is \$230,000.00, everything related to the leak has been paid, waiting for an invoice from Tata & Howard for their technical services. We have not completed this project yet.

The Kettle Brook design work is still ongoing. Soil boring being done this week

Continuing the changing out the media with the well and there have been issues. Welding needed to be done to a tank and now we have a leak to a manway. One way to fix would involve removing all the new media. Instead, we are working with another product while the media is in the tank for now. These are older steel tanks from the 2000's and may need to look into the future so that the tanks would need replacement. The well will remain offline until the epoxy hardens and perhaps will be back online by the 1st of the year.

Capital Strategic Solutions is ongoing. They are reviewing the asset management plan and the water distribution plan with costs and projections for the future. We should see a draft by the end of January.

The Lead Service line has not begun with the second phase. May be closer to spring due to moratorium of opening roads in winter months.
