Commissioner DellaCava asked if there is a rough estimate of how many will be paid. Per Treasurer Wood it will vary each month as it all depends on who pays. Commissioner DellaCava motions to accept the Treasurer Report. Seconded by Chairman Manseau. All in favor. approved.

- E. Sewer Rate Relief Fund Per Treasurer Wood the amount to be received will be \$1,188.00. Last year was about \$780.00.
- F. FY 22 Budget Per Superintendent Morris no changes since the review of the last meetings. There is a slight savings in operating expense from the Upper Blackstone of \$14,912.00 and City of Worcester \$35,000.00. He has not heard back from USDA as it is in the hands of Washington D.C.

The budget is \$832,959.17 that includes debt service. There will be a \$60,548.08 reduction from last year.

Commissioner DellaCava asked if it best to now combine the sewer and water. Per the Superintendent it is up to the entire Board to have this discussion. Commissioner DellaCava motions to move forward to accept the budget for the Annual Meeting. Seconded by Commissioner Lemieux. All in favor. Approved.

Commissioner Lemieux entered the meeting at 7:12 pm

G. Annual Warrant Articles – Commissioner Lemieux motions to approve the Annual Warrant Articles. Seconded by Commissioner DellaCava. All In favor. Approved.

IV. ADMINISTRATION

A. City of Worcester Agreement – Per Superintendent Morris the contract with the city expired, he reached out to Phil Guertin to confirm. The current will stay in effect. The Board needs to submit a letter for renewal, reviewed, approved by the Board and Legal. The contract to be used would not be the old contract as it was written when the system was built, a new contract needs to be written how it applies to the Sewer District now. Commissioner DellaCava motions to approve. Seconded by Chairman Manseau. All in Favor. Approved.

V. OPERATIONS -

A. Superintendent Report –

In the last month working on in house maintenance referring to pumping stations and rebuilding that consists of changing out gaskets and seals to ensure all working.

Sewer jetting will be spring, summer or fall.

Opening of manholes covers to determine I/I rebuilds in next couple of weeks for the best approach for the coming year.

The master meter at the city line was recalibrated. The meter is operating properly without any issues. The cleaning of the flow meter is every other week. Overall flows a little higher last month to be expected with some rain and melting that was going on and generates flows with I/I.

For the 1st quarter of the calendar year approximately \$46,000.00 in sewerage. We are under budget and staying on target for what has been budgeted for and should be in good shape for next three months.

February 1, we did 6 million gallons of flow with 3 ½ inches of rain, the heavier portions was February and early March. The system is in decent shape. No major issues or problems.

In talks with USDA for reamortization and reduction in interest rate. As of right now all three payments have been made and hoping they will give the reduction for the coming year to allow us to perhaps allow some rate reduction to our customers. Did a follow up with McGovern's office and to get back to him with any information.

Per Chairman Manseau the rate reduction for the district should stay hold the line instead of having a reduction?

Per Superintendent Morris we can look at once we know what the USDA figure would be. With the reamortization it extends the loan out 10 years and interest rate to 2%. With this we review the rates if able to make a reduction. Need to take little by little to see if USDA says yes or no

He has received the Draft of the Town Wide Water/Sewer study by Weston & Sampson. The draft does not have the recommendations to where to move forward yet. It is of the current situation of what each district is in currently. He is to forward the draft to all of the Commissioners for their review and discuss later.

Commissioner Dellacava asked if there is a deadline on the draft. Per the Superintendent the town is looking to have a joint meeting to review the draft and then they will finish.
